To maintain a parking permit, students **must maintain academic eligibility**, not having any failing grades for the previous marking period.

Students who accumulate an excessive number of tardies to school, excessive absences or those who leave school without permission during the school day will face the permanent loss of their parking privilege. Students who fail to comply with parking/driving regulations on school property will face monetary fines, suspension of driving/parking privileges, or further disciplinary actions as determined by the administration.

## PARKING REGULATIONS

### **PARKING AT NORTH CARROLL HIGH IS A PRIVILEGE FOR STUDENTS NOT A RIGHT!!!**

- I. Students must be academically eligible (no failing grades for the previous marking period) & conduct eligible when applying for a parking permit and **must maintain eligibility to keep the permit** throughout the year.
- II. A student who owes an obligation will not be issued a parking permit until the obligation has been cleared through the main office.
- III. Applications for parking permits for juniors and seniors only. The permit number and registered vehicle and license tag number must agree with the school's records or the permit may be revoked. **Students cannot share or loan permits.**
- IV. Parking Regulations
  - A. Parking permits (hang tags) must be displayed on the rear view mirror for admission to the parking lot. Lot monitors will scan cars on a regular basis and ticket or deny parking to anyone who does not display a permit. Student parking is permitted only on the student lot (Hampstead side of building) and only in designated spaces. **Students are not allowed to park in the faculty lot.**
  - B. **Cars parked in the upper lot (band practice area) must be removed by 3:00 p.m.**
  - C. Upon arrival at school, student drivers are to park and lock their cars and enter the building. Students are not to congregate at cars or elsewhere on the parking lot.
  - D. Students are not to be in the parking lot or at their cars during the school day. Should students need to go to their vehicles during the school day, they must request a pass from an administrator.
  - E. Student drivers will notify the school of any change of vehicles and update their parking permit information as necessary.
  - F. **Students receiving more than three (3) tickets may lose their driving privileges.**
- V. Driving Regulations
  - A. The speed limit on school property (and Panther Drive during arrival and dismissal) is 15 mph.
  - B. Student drivers will obey all traffic routes. The arrows on the parking lot are designated to allow students exiting to Route 482 to exit from the north end of the lot and students exiting toward Hampstead to leave through the south end of the lot.
  - C. **Leaving school and/or transporting student(s) from campus during the school day (truancy) will not be tolerated and will result in the loss of the driver's parking permit permanently.**
  - D. More than three (3) tardies and /or un-excused absences will result in the suspension of the parking permit.
  - E. **Disrespect to any parking lot staff monitor will result in the permanent loss of your permit.**
  - F. **Replacement fee for lost or stolen permits is \$10.00.**
- VI. **The administration reserves the right to revoke the driving privilege of a student who fails to comply with the above regulations. Fees for revoked parking permits will not be refunded once revoked.**
