



## 2020 SCHOLARSHIP APPLICATION

It is the mission of the Greater Mount Airy Chamber of Commerce (“Chamber”) to promote business and professional services in the greater Mount Airy, Maryland area. To further our mission, the Chamber has allotted \$2,500 for a scholarship (“Scholarship”) to be awarded to a select student. An additional scholarship(s) totaling up to \$6,500 may be awarded at the discretion of the Chamber. The award is an outright gift, not a loan to be repaid or a salary to be earned by performing certain duties. It will be awarded as a one-time payment made directly to the institution of acceptance upon presentment to the Chamber of evidence of registration at a qualified educational institution. \* The Scholarship is a one-time gift and is not renewable in subsequent years, however, students may reapply regardless of previous award. Though it is expected that a student will be chosen to receive the Scholarship, the Chamber may choose to not make an award in any given year. The Scholarship is not intended merely to further the education of an aspiring student, but to recognize and assist those students who share the vision and values of the Chamber and show potential of contributing to the greater Mount Airy community.

The candidate, however, must be eligible for and committed to entering an institution of higher learning the immediate semester following the announcement of the winner(s). The selection process will be conducted by the scholarship committee of the Greater Mt. Airy Chamber of Commerce. Family members of the Greater Mt. Airy Chamber of Commerce will be considered but without preference over other candidates.

All applications must be postmarked on or before **April 24, 2020**.

Please ensure that all required attachments listed at the end of this application are submitted. Confirmation of the student’s enrollment will be required. Final awards will be determined in late April, 2020 and presented at High School awards ceremony if applicable and/or at the May Chamber Meeting. **Note:** Winners are strongly encouraged to attend the May general membership meeting to accept their scholarship.

### ELIGIBILITY

You are eligible to apply for The Greater Mt. Airy Chamber of Commerce Scholarship if

- You are a U.S. Citizen and a resident of the Greater Mt. Airy region. (A preference *may* be given to Mt. Airy residents in the selection of the winner, but Mt. Airy residency is not a requirement to apply.)
- You are applying to, have been accepted in, or are already enrolled in, an accredited higher education facility: community college, trade school, four-year College or University, or Graduate School.
- You are graduating from High School, have successfully completed a Literacy or GED Program, or are a high school graduate.

## REQUIRED ATTACHMENTS

Application and the following required documents must be postmarked by **April 24, 2020**

1. *If you are applying as a high school graduate*, your high school **TRANSCRIPT** showing GPA and class rank.
2. *If you are applying as a graduate of a literacy or GED program*, your **CERTIFICATE OF PROGRAM COMPLETION** or other evidence (such as a letter from the provider) demonstrating successful completion of the program.
3. *If you are not yet enrolled in college*, a copy of your **COLLEGE ACCEPTANCE LETTER(S)**.
4. *If you are already enrolled in college*, a **COLLEGE TRANSCRIPT** showing current GPA.
5. A typed essay of 500 - 1,000 words. This **PERSONAL STATEMENT** should describe your individual character and accomplishments, career and educational goals, why you believe you deserve The Greater Mt. Airy Chamber of Commerce Scholarship.
6. At least one, but no more than three, **LETTERS OF RECOMMENDATION** written on your behalf by persons not related to you (such as teachers, counselors and supervisors). One of the recommendations must come from the supervisor of a recent work or community service experience. The letters should be delivered in sealed envelopes with the application, and the persons signing the letters should also write their signatures across the flap of the sealed envelope. Each of your references should include a telephone number where he or she can be reached during the business day.
7. In addition to your typed essay (#6) on a separate document describe:
  - **EXTRACURRICULAR ACTIVITIES** you have participated in during the past four years, such as student government, sports and clubs, including offices held and any special honors you have received.
  - **COMMUNITY SERVICE** activities in which you have participated in the past four years, including the number of hours per week spent on the activity and how many days, months, or years you participated in the activity; and why you chose to serve the community in this way. If applicable, please describe Mt. Airy region community service.
  - **WORK EXPERIENCE** you have had in the past four years, including your length of employment and the number of hours you worked. Please explain why you chose these jobs.

It is the responsibility of each scholarship applicant to submit all of the required items on or before the application deadline of **April 24, 2020**. Due to the volume of scholarship applications, The Greater Mt. Airy Chamber of Commerce cannot assemble items that are missing from applications. For that reason,
